- Month 12 draft position is a £29.8m surplus. May be small changes as final accounts work ongoing.
- Represents a £0.6m improvement to the M11 forecast; £5m improvement in CHFT due to timing of Project Echo, mostly offset by agreed reductions in surpluses in other organisations.
- Change in forecast agreed with NHSEI

Provider capital – ICS system envelope

- ICS envelope: capital spend of £162.0m which is £7.1m over plan. This primarily relates to £5.8m RAAC issue at Airedale, partly offset by slippage in other organisations, and £2m allowable overspend in CHFT where inter-ICS transfer expected. Further £0.1m over-spend agreed at Month 12.
- £7.1m over spend agreed by NHSEI.
- Forecast over-spends in some organisations being offset by underspends in others to ensure maximum ICS spend.

Provider capital – national schemes

- National capital: forecast spend of £58m which is £18.1m under plan – this excludes additional TIF forecast, now reported separately. Under-spend in line with Month 11 forecast. Key components:
 - i) CHFT £2.6m STP scheme slippage now transferred to fund operational capital (agreed with NHSEI)
 - ii) (£3.6m) slippage on scheme in LYPFT linked to Complex rehab business case review. Delayed under later in year
 - iii) (£15.0m) under-spend at LTHT; Building the Leeds way HIP scheme and Pathology STP scheme and LIMS.
 - iv) The above schemes will be re-phased in agreement with NHSEI.
- TIF schemes forecast to spend £27.3m against plan of £28.8m; under spend of £1.5m. In line with Month 11 forecast, and agreed with NHSEI
