Council of Governors

Council of Governors Nominations Committee '

The Council of Governors Nominations Committee met on 7 June to recommend the appointment of Dr Linda Patterson OBE as Chair of the Trust. This was confirmed by an extraordinary meeting of the Council of Governors on 9 June 2022.

Dr Patterson will take up post on 1 July 2022, however due to pre-arranged annual leave between 11 July-15 August, it had been agreed that the Interim Chair, Carole Panteli, take up an interim Deputy Chair role until 15 August to provide the Trust with continuity of leadership.

Governor Service visits

Due to the lifting of many COVID-19 infection prevention restrictions, face-to-face Go See visits have resumed. This has been well received by staff and Board members and the Chair would be delighted to host visits for Governors. This can be arranged at the request of Governors and is an excellent opportunity particularly for new Governors, to broaden their understanding of our work.

Board recruitment

Due to the retirement of both the HR Director and Director of Corporate Affairs, and the promotion of the Chief Operating Officer (COO) to another organisation, the Chief Executive has led the recruitment to these Executive posts.

Following a rigorous recruitment process Bob Champion, formerly the Interim Director of HR has been successfully appointed as the Chief People Officer. The CEO was not able to appoint to the COO and Director of Corporate Affairs posts, however the Interim COO has agreed to stay with the organisation for longer and the Trust has appointed Gilbert George, a very experienced Interim Director of Corporate Affairs who joined the Trust on 27 June. These experienced Interim Directors will provide senior leadership and service continuity to the Trust whilst a further recruitment process gets underway.

Strategic

The Trust, including the Board, continues to proactively engage in the developing Integrated Care agenda, informed by the Government's Health and Social Care Bill. The statutory arrangements became operational on 1 July 2022 and our Trust continues to be an active member of the Bradford and Craven Integrated Care Partnership (ICP) as a Place- based partnership as well as the West Yorkshire Integrated Care system (ICS).

The Interim Chair attended a Regional roadshow on 4 July hosted by NHSE/I where Amanda Pritchard, CEO of the NHS, outlined the challenges facing the NHS over the coming year, particularly financial constraints and elective waiting times. She also encouraged ICS and Place systems to grasp the opportunities offered to partners to work in an integrated way to address Health inequalities and transform services for people.

BD&C Place

The Partnership Board is now meeting as a formal body, members include all senior leaders across the Bradford and Craven District including the Trust CEO and Chair. The new Place System committees have been established with Non-Executive membership drawn from the three provider Trusts across Bradford District &Craven, taking up roles as independent members of these committees. Two BDCT Non-Executive Directors have been recruited, joining the Finance Committee and Quality committee.

Children and Young People Services across Bradford District

As reported to Governors in May, Bradford Council is creating a council-owned children's company as part of its ongoing commitment to improving its children's services. Establishing the company will ensure that children and young people feel the impact of improvements even sooner, which will result from increased investment in services and closer working between local children's service professionals and national expertise.

Board members continue to work closely with Local Authority leaders to ensure Children's services are delivered safely. The Chair meets monthly with the Leader of the Council and the Chief Executive is taking a leadership role across the District on behalf of the Place Partnership Board.



National Independent Inquiry into Child Safeguarding

An independent Child Safeguarding Practice review panel led an inquiry into the tragic murders of two children, Star Hobson and Arthur Labinjo Hughes.

This report was published in May and members of the panel held a webinar on the 28 June attended by Health and Social Care leaders from Place including the Trust Interim Chair to discuss the findings of the report and the recommendations made to the Secretary of State. A number of these recommendations could fundamentally change the approach to Child safeguarding at a local and National level.

BD&C partners were able to share the changes already actioned across the partnership to strengthen Child safeguarding, building on the lessons learnt from the terrible murder of Star Hobson.

Outcomes focussed

Partnerships

Due to the revised date for the statutory changes to be at ICS and ICP levels, the Board approved the revised Strategic Partnership Agreement (SPA) at the June private Board meeting. The Chief Executive and Interim Chair continue to attend the West Yorkshire ICP and Place strategic groups as part of the new NHS Integrated Care system.

WY&H Committee-in-Common

The Trust has continued to contribute via the Interim Chair to the WY&H Committees-in-Common for Mental Health, Learning Disability and Autism. This was on a rotational Chair arrangement (chaired previously by Cathy Elliott), with the role now passed to the Chair of Leeds Community Healthcare NHS Trust. The Committee-in-Common has undertaken to review its role in response to the ICS proposals to ensure it remains relevant and influential in the new strategic partnership arrangements.

West Yorkshire Community Provider committee

The Interim Chair has continued to meet with Chair colleagues from neighbouring West Yorkshire community Provider Trusts to scope a new community provider committee which will ensure the importance of community service provision is understood and relevant for the WYIC Board.

Having reviewed the Hambleton report, originally commissioned by BDCT and partners, the WY provider committee are keen to undertake a similar piece of work with Dr Hambleton to review the community offer across the West Yorkshire footprint.



People

Board members continue to engage with staff via virtual meetings such as the Aspiring Cultures Network and the Strategic Equality, Diversity Inclusion and Governance Group.

Board members present and/or attend weekly Executive broadcasts for the workforce which cover a range of current topics linked to the pandemic or schedule of activities. The most recent weekly broadcasts have related to COVID-19 matters, in particular the Government mandated vaccination of all NHS staff (see further information below).

Membership Development Committee

The re-established Membership Development Committee met on 17 June 2022 and the meeting focussed on youth involvement with the Trust. An update on this work will be provided later in the meeting.

Governor Elections

As reported to the June Council of Governors meeting, four new Public Governors have now joined the Council of Governors. In addition to this, Cllr Wendy Hull has replaced Cllr Richard Foster as the Appointed Governor for Craven Council, following the end of Cllr Foster's first term. The Trust is looking forward to working with all of the newly appointed Governors and welcomes them on board.

The Trust is also in the process of running a Staff Governor election, hoping to elect two Clinical Governors and one Non-Clinical Governor. The deadline for nominations is 19 July 2022 with the results announced on 6 September following voting for any contested posts.

Annual Members Meeting

The Annual Members Meeting will take place on Thursday 15 September, from 2.45pm until 4.30pm. This will be an in-person meeting in Bradford and the venue will be confirmed in due course.
